The medal winners of the <b>general competition</b> of Olympic Games, the World Championships and European Championships (C II)(gold-silver-bronze) and also the <b>gold-medal</b> winners of the World Championships and European Championships of the Team-competition (C I) have the right to participate additional to the qualification. The Organizing Federation is allowed to enter max. 4 gymnasts.  The LOC will only cover accommodations and meals for participants in Grand Prix (1 gymnast, 1 coach, 1 judge). All extra persons are to be paid by their resp. Federations.
