FEDERATIONS INVITED	The Organizing Member Federation will invite all Member Federations from the South American Gymnastics Confederation: ARG, BOL, BRA, CHI, COL, ECU, PAN, PAR, PER, URU, VEN.
AGE LIMITS	<ul style="list-style-type: none">• Senior (DMT and TRA) With valid FIG licence and CONSUGI licence.
JUDGES AND JURIES	The number of Judges' panels may be decided by the Local LOC and the Superior Jury of the event depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw – directed by the Superior Jury – from the judges present at the event.

	<p>Each participating federation must provide minimum two judges (minimum category IV). Failure to do so will result in a fine of 1000 U\$\$ to be paid to the organizing member federation in order to cover the expenses of inviting an additional judge to the event.</p> <p>All judges must have a current valid FIG brevet at the time of the event.</p>

ENTRY FEES	<p>The cost for the entry fee is U\$\$ 25 per gymnast. The participating federations must pay for all entry fees. At the time of the Definitive registration (2 months prior to the event) 100% of the entry fee must be paid to the LOC. The entry fee is not refundable. Entries without payment of the entry fees will be considered as invalid and will be refused.</p>						
ACCREDITATION	<p>All delegations will be guided to the hall (accreditation desk) upon arrival to Bogotá. The accreditation will take place at the venue upon arrival. The accreditations will only be handed out to the head of delegation. All delegations must deliver national anthem, flag, insurance, passports of all members, FIG Card Licence and CONSUGI Card Licence.</p>						
EVENT FORMAT	<p>This South American Championship will be run in the following two (2) disciplines and two (2) levels:</p> <ul style="list-style-type: none"> • Individual Trampoline • Double Mini • Synchronized Trampoline <p>Competition will consist of Qualifications and Finals.</p> <p>Participation in the Qualifications:</p> <ul style="list-style-type: none"> • All competitors must take part in the qualifications. • No qualifications must be held if there are less than 9 participants per discipline. • In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2015 FIG Technical Regulations) shall be applied. <p>Participation in the Finals:</p> <ul style="list-style-type: none"> • The top eight gymnasts or pairs from the qualifications qualify for the finals. • There will be no limits of participants per federation in the finals. • In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2015 FIG Technical Regulations) shall be applied.

MEDICAL SERVICES	<p>The LOC will provide first aid medical services during the training and competition.</p>
VISA	<p>Please verify immediately with your travel agent or the Colombian Embassy or Consulate in your country if a visa is required for your travel to Colombia. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 15th October to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).</p> <p>Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: USD 60 per person.</p>
INTERNATIONAL TRANSPORTATION	<p>The participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by October 15th 2015</p>
LOCAL TRANSPORTATION	<p>Delegations booking accommodation through the LOC will be free offered transport:</p> <ul style="list-style-type: none"> - From El Dorado Airport (IATA Code: BOG) to the competition venue or hotel and back provided notifications of flights details has given prior October 15th 2015 - From Hotel to the competition venue
ACCOMMODATION	<p>OFFICIAL HOTEL from LOC</p> <p>The costs per person/night in these hotels are as follows:</p> <p>100 U\$S (single room, full board)</p> <p>70 U\$S(double or triple room, full board)</p> <p>120 U\$S (single room, full board, extraofficial person)</p> <p>90 U\$S(double or triple room, full board, extraofficial person)</p> <p>All the reservation must be made bay LOC.</p> <p>Both the airport transfer by bus and the ticket for the banquet are already included in these prices.</p> <p>While the Accommodation Form must be returned to the LOC by September 30th 2015 at the very latest, the Hotel rooms will be allocated on a “first come, first serve” basis. The participating federations must pay for their accommodation costs. At the time of the Nominative registration (1 month prior to the event September 30th 2015) 50% of the accommodation costs must be paid to the LOC. Entries without the payment of the 50% of the accommodation costs will be considered as invalid and will be refused. The remaining 50% of the accommodation costs must be paid by October 29th 2015.</p>

MEALS	All meals will be provided at the official hotels. Free local transportation will allow all delegations to arrive on due time to the lunch and dinner times.																
CANCELATION POLICY	<p>Rooms with or without full board cancelled until 30th September 2015 at the very latest will be subject to a cancellation fee of 0%.</p> <p>Rooms with or without full board cancelled from 30th September of 2015 until 28th October of 2015 at the very latest will be subject to a cancellation fee of 50% to be paid by the Federation concerned.</p> <p>Rooms with or without full board cancelled from 29th October of 2015 until the arrival of the delegations on site or "no show" will be subject to a cancellation fee of 100% to be paid by the Federation concerned.</p>																
FINAL BANQUET	<p>Final banquet will be organized at Hotel.</p> <p>All individuals booking their accommodation via the LOC will get their tickets without any additional payment.</p>


