ACCREDITATION	The Accreditation system identifies the participants, who have permitted access.
	There will be an access control in each area. The participants have to wear this
	accreditation inside each area, at all times.
	During the accreditation, the Heads of Delegation are required to check the
	names of the members of their delegation, to present their valid FIG Licenses, to
	hand over their flag and national anthem of their country, as well as to settle
	outstanding payments to the Organizing Committee.
	They must bring along their payment receipts, which have been made by bank
	transfer.
MEDICAL	Heads of Delegation are required to present their proof of medical insurance of
INSURANCE	every member of their delegation (including technical officials) or to pay the
	accident insurance in Mexico of \$35.00 USD (thirty five USD), per person, which covers the training and competition days, for all the official period of the event
	(this insurance does not cover any illness).
	In the case of not having the medical insurance, the participation to the
	event will not be allowed.
	The Host Federation, the Organizing Committee, the FIG and PAGU will not be
	held responsible for any liabilities in case of accidents, illness, repatriation and
	the like.
	The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid
	insurance coverage against illness, accidents and for repatriation for all the
	members of their Delegation.
	The LOC will verify the insurance upon arrival of the delegation members (e.g.
	cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.

FIG LICENSES	All the competitors must have their valid FIG license at the moment of the
	competition. The LOC will be responsible of revising the validity of the licenses.
REGISTRATIONS	All the registrations must be sent mandatorily to the e-mail of the LOC and to
LOIOTIATIONO	PAGU's e-mail as well.
	According to PAGU 2013, the cost of the registration fee is \$50.00 USD per
	gymnast, regardless the number of categories in which the gymnast has been
	registered.

Registration Deadlines:

- Provisional Registration: Friday, October the 9th, 2015.
- Definitive Registration: Friday, October the 30th, 2015.
 <u>Note</u>: The definitive registrations will not be accepted if the 50% of the total of the hotel accommodation and meals has been made, as well as the 100 % of the registration fees have been paid.
- Nominative Registration: Friday the 13th of November, 2015.
 <u>Note</u>: The nominative registrations will not be accepted if the remaining 50% of the total of the hotel accommodation and meals has been made.

The registrations will only be valid if they are done by the National Federations affiliated to PAGU, and accompanied by the payment receipt and the respective official formats. Extemporaneous registrations will not be accepted upon completion of the definitive registration deadline.

The cost of the accreditation for additional persons (Coaches, Team Leaders, Doctors, Physiatrists and guests) will be of \$100.00 USD (One Hundred USD) each, and this accreditation grants the same rights as to the official members of the delegation.

AGE LIMITS

Senior: 18 years old in the year of the competition (born in 1997 or earlier).

Age Group 2: 15 –17 years old in the year of the competition (born from 1998 to 2000).

Age Group 1: 12 –14 years old in the year of the competition (born from 2001 to 2003).

COMPETITION RULES

A gymnast may be registered, maximum, in 3 categories.

The AER Pan American Championships consists of a qualifying and a final round in each category.

Qualifying Round:

Maximum 4 units from one same federation in each category.

Final Round:

The best 8 classified gymnasts/units will pass to the finals. Maximum 2 per country and category.

If the organizing Federation has not qualified a gymnast in any category, it will be able to ensure a participation in the category of its choice.

Therefore, the maximum participation in the final round is of 8 + 1 in one category, and 8 in the other 4 categories.

The participant with the Wild Card must compete in the qualifications of the respective category and will be eligible to receive medals.

JUDGES

All judges must have a current valid FIG brevet.

Every Federation must send, at least, 1 judge who will judge during all the phases of the competition.

For the purpose of having an adequate number of qualified judges in the competition, participating Federations are invited to send more judges than the required ones. There will not be a maximum quantity of judges per Federation.

Those Federations, which do not participate with at least 1 judge, will have to pay the amount of \$1,000 USD (One Thousand USD) in order to cover the expenses of a guest judge. This will have to be informed and paid to PAGU at the moment of the definitive registration.

The judges panel must have a minimum of:

- 4 Artistic Judges
- 4 Execution Judges
- 2 Difficulty Judges
- 1 Chair of Judges Panel

The Technical Representative of PAGU will act as the President of the Superior Jury.

Please confirm immediately with your travel agency, embassy or consulate if in your country a visa is required to enter Mexico. In case you require a visa, the LOC will send an official invitation letter so you can transact the respective visa before the Mexican authorities in your country.

The application form must have full name as it appears on the Passport, gender, Passport number, Passport expiration date, place in which the visa will be transacted and the arrival and departure information of every member of the Delegation.

The deadline for the request of the invitation letter is Friday the 30th of October. 2015.

INTERNATIONAL TRANSPORTATION

Every National Federation will be responsible of the international transportation of the members of their Delegation.

The official arrival airport will be the International Airport of Mexico City (MEX).
