PARTICIPATION	The International Open Competition consists of qualifications and finals. There will be qualifications only for the categories and age groups with more		
	than 9 participants. Participation in the finals:		
	The top eight gymnasts per category and age group, will qualify for the Finals.		
	In case of a tie in any place, the tie-breaking rules as set by FIG for the World		
	Championships apply. The LOC may cancel the competition in the respective category if at the time		
	of the definitive entry, there are less than 3 countries registered in a category. In case of such a cancelation, the LOC must reimburse, in full, the entry fee and payments made for accommodation. Should flights have to be cancelled due to the above, the risk is at the charge		
	of the participating member Federations.		
SIZE OF THE DELEGATION AND FIG LICENSE	The number of participants by nation, category and age group is not limited. All AG1 (12-14 Years), Juniors / AG2 (15-17 years) and Seniors gymnasts in good standing with the correct age and holding a valid FIG license may participate.		
	The LOC will be responsible for checking the validity of all gymnasts Licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.		
AGE LIMITS	AG1: 12-14 Years / AG2-Juniors 15-17 years / Seniors 18 + years		
CATEGORIES	IW / IM / Mix Pair / Trio / Group / Aerodance / Aerostep (all age limits)		
JUDGES & JURIES	The number of Juries (judges' panels) may be decided by the Organizing Member		
	Federation depending on the number of participating competitors and judges.		
	The Juries are set up by a draw and directed by the Technical Delegate from the judges present at the event. Priority will be given to the judges of the		
	highest category. If, on the day of the competition, there are no sufficient numbers of judges in the requested categories, the Technical Delegate may take whatever action needed to secure the running of the event. Each participating federation must provide minimum one judge Cat. 1, 2, 3 or 4 with current valid brevet. Failure to do so, will result in a fine of Swiss Francs 2'000 to be paid to the LOC until the Definitive Registration date (22-12-2014).		
	All judges must have a current valid FIG brevet.

The invited participating federations must pay for the transportation expenses of their delegation members until 22, December, 2014.

The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before December 22 nd 2014 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.	
INSURANCE	The Host Federation, the Local Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.	
	The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.	
	The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). All delegations must deliver 2 music CD's for each routine, difficulty elements list for each routine, national anthem and flag, insurance declaration, passports of all members and FIG License Card Check.
