<b>AGE LIMITS</b>	<b>WAG - Junior: 13-15.</b>

<b>JUDGES AND JURIES</b>	Every participating Club and/or Federation must provide 1 judge. <b>All judges must have a current valid FIG brevet at the time of the event.</b> In the case of a missing judge the team must pay a 100 EUR fee.				
<b>COMPETITION FORMAT</b>	The team is composed from 3 girls (2 + 1) Team and all-around competition - modification rules for juniors.

<b>INSURANCE</b>	All the competitors compete and train on their own risk, so please make sure that your gymnasts have insurance policy.  The Host Federation and the LOC will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.  The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the

<b>INTERNATIONAL TRANSPORTATION</b>	<p>Each team has to pay for their own travel expenses.</p> <p>The Travel Schedule Form must be returned to the LOC with Nominative registration till <b>1<sup>th</sup> of April 2018</b>.</p>
