**INTERNATIONAL TOURNAMENT, SENIOR (FS MEN)  
CUP OF AKHMAT KADYROV MEMORIAL  
GROZNY, CHECHEN REPUBLIC, RUSSIA  
17-21 October 2019**

**1. General conditions**

The Tournament will be held in accordance with the provisions of UWW Regulations in organizing the UWW International competitions.

The tournament will be focused at propaganda and development of freestyle wrestling in the Chechen Republic, Russian Federation and in the world.

The International tournament in freestyle wrestling of the Republican wrestling Club “Akhmat” in memory of the first President of the Chechen Republic Hero of Russia Akhmat A. Kadyrov will be organized by the Chechen Republic Government, Wrestling Federation of Chechen Republic and Wrestling Federation of Russia.

**3. Dates and Venue**

The Tournament will be held on 17-21 October 2019.

Arrival day is 17<sup>th</sup> of October 2019

Departure day is 21 of October 2019.

Venue: Grozny, Volleyball Palace after Uvaisa Akhtaev.

**4. Participants and composition of official sport delegations**

The athletes from National Wrestling Federations not having any debts before the United World Wrestling will be allowed to compete.

10 wrestlers of National Wrestling Federation are allowed to compete. It is permitted to have a doubling only in two weigh categories (strictly as per these Regulations).

**5. Entries deadlines**

Preliminary entries (number of participants) are to be sent to Wrestling Federation of Russia **not later than on 20<sup>th</sup> of September 2019.**

Final nominative entries are to be sent to Secretariat of **Tournament until the 17<sup>th</sup> of October 2019 not later than 15:00 of local time.**

## **6. Technical conditions**

The tournament will be held according to the UWW Rules in the following weight categories: 57, 61, 65, 70, 74, 79, 86, 92, 97, 125 kg., tolerance of 2 kg.

Teams' heads are to present the following documents to the Secretariat:

- Passport or identification document;
- Entry for participation
- UWW valid license

## **7. Referees**

Referees of International categories will be allowed to participate in the Tournament.

## **8. Awarding**

The prize fund for the Tournament is provided from the Charitable Foundation after A.A. Kadyrov.

The winners, prize winners & coaches are awarded with corresponding medals and diplomas.

The winners, prize winners & coaches are awarded with money prizes.

There will be provided special prizes in the following nominations;

1<sup>st</sup> place - \$ 5000.00, coach – \$ 1000.00;

2<sup>d</sup> place - \$ 3000.00

3<sup>d</sup> place - \$ 1500.00

3<sup>d</sup> place - \$ 1500.00

## **9. Official Ceremonies**

The Sport delegations representatives will take part in the Opening and Closing Ceremonies, press-conferences and other events as per Tournament official Program. Each delegation will provide the Organizers with a flag 100x150 cm and National anthem, which will be handed over to the Organizing Committee on the date of arrival.

## **10. Financial conditions**

The Organizing Committee to provide UWW Regulations requirements in organizing International competitions will cover the following expenses on:

- Meeting and seeing off the delegations at the airport and railway station in Grozny as well as fetching them to the places of accommodations and competitions:
- Training and sauna etc.;
- Accommodation and food;
- Medical services to the tournament participants
- Accommodation, food and travel costs of the UWW representative, referees of the teams' members, guests of honor as per the list agreed upon with the Wrestling Federation of Russia:
- Food for referees, operating personnel;

Travel costs of sports delegations to Grozny and back will be covered by the participating National Federations.

## **11. Mass Media**

The Press center for International representatives of mass media will function during the Tournament.

## **12. Visas**

Entry visas to Russia will be issued to all participants of the tournament in the Embassies and General Consulates of the Russian Federation according to preliminary prepared official invitations provided that all necessary documents: nominative entry, copy of passport (of all pages) having been sent until the 20<sup>th</sup> of September 2019.

## **13. Miscellaneous**

The parties should be governed by the UWW Constitution and Regulations in case of arising issues out of these Regulations.
