| SIZE OF DELEGATION | <p>The maximum size of a Grand Prix delegation is as follows:</p> <table border="1" data-bbox="662 548 1257 654"> <tr> <td>Individual gymnasts</td> <td>1-4*</td> </tr> <tr> <td>Coach</td> <td>1</td> </tr> <tr> <td>Judge</td> <td>1</td> </tr> </table> <p>* National Federations may register to participate as follows:</p> <ol style="list-style-type: none"> 1) Individual gymnasts will be invited according to the Grand Prix ranking list after the last 2020 Grand Prix in Brno (RGI): top-12 gymnasts of each apparatus final (nominative invitations). 2) 2020 Grand Prix organizing Federations may register 2 individual gymnasts. 3) Host country Ukraine may register 4 individual gymnasts. 4) Medal winners of the All-Around competition of the Olympic Games, the last World Championships or the last European Championships have the right to participate additionally. 5) Other Federations may register 1 individual gymnast (the best national gymnast). <p>The LOC will cover the expenses (accommodation, meals, local transportation) for 45 gymnasts in total. If the number of registered gymnasts exceeds 45, the LOC will cover the costs for those who registered earlier (except gymnasts from top-12 of the ranking list, granted they have registered before the deadline of the Definitive registration).</p> <p>The LOC will ask to reply to the nominative invitations by the deadline of the Definitive registration.
