	Each federation must send at least 1 judge.	
JURIES	All judges must have a current valid FIG brevet for the current cycle at the time of the event.	
	The number of Judge's panels will be decided depending on the number of participating competitors and judges.	
	The Juries will be set by a draw from the judges present at the event. The priority will be given to the judges of the highest category.

EVENT FORMAT	The competition consists of Qualifications and Finals in all Age Groups and all categories. In case that there are less than 9 participants per category in the Qualifications, no Qualification is necessary.	
	QUALIFICATIONS: There is no limit on the number of participants per category and nation in the Qualifications.	
	FINALS: The top 8 (eight) competitors from the Qualification in each Age Group (SEN, AG2) and category (IW, IM, MP, TR, GR, DANCE & STEP) will take part in the Finals (maximum two per category and nation). In addition, if the organizing Federation has not qualified competitors in any category, it may nominate max. 1 participant in each category in each Age Group of its choice.
