FEDERATIONS INVITED	<p>The Spanish Gymnastics Federation invite all Member Federations according to the following principles:</p> <p>The International Tournament Ciudad de Valladolid is an event open to all clubs affiliated in their respective National Federations, as well as representatives of National and/or Regional federations.</p>																																
AGE LIMITS	<ul style="list-style-type: none"> • Age Group: 11-12, 13-14, 15-16, 17-18 • Senior: 17 and plus <p>All participants must hold a valid FIG licence</p>																																
JUDGES AND JURIES	<p>The number of Judges' panels may be decided by the Local LOC and the Superior Jury of the event depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw – directed by the Superior Jury – from the judges present at the event.</p> <p>Each participating federation/club must provide minimum one judge (minimum category IV) per discipline in which they participate (TRA and DMT). At the time of the Definitive registration (2 months prior to the event) 100% of the entry fee must be paid to the LOC. The entry fee is not refundable.</p> <p>Entries without payment of the entry fees will be considered as invalid and will be refused.</p>
ACCREDITATION	<p>All delegations will be guided to the hall (accreditation desk) upon arrival to Valladolid.</p> <p>The accreditation will take place at the venue upon arrival. The accreditations will only be handed out to the head of delegation. All delegations must deliver national anthem, flag, insurance, passports of all members and FIG Card License.</p>

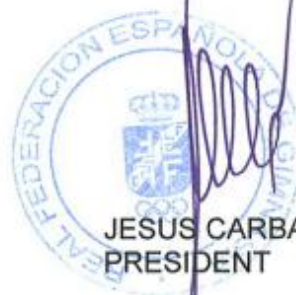

VISA	<p>Please verify immediately with your travel agent or the Spanish Embassy or Consulate in your country if a visa is required for your travel to Spain. The LOC will be happy to assist each delegation member with an official invitation letter, provided that the request is made before July 8th 2015. The request must include the full name, date of birth, gender, function, passport number, passport expiry date, and the arrival and departure dates of the delegation member as well as the city the visa application letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: 35 euros per person/day.</p>
