FEDERATIONS INVITED	Departure of Delegations. All FIG Member Federations in good standing who have paid their annual Membership Fee for Trampoline Gymnastics are invited. All competition groups and events are also open to clubs and regional federations.		
SIZE OF DELEGATION AND FIG LICENSE	Only gymnasts in good standing with the correct age may participate. The Organizing Committee will be responsible for checking passports or identification cards. Limit of competitors – 400 First come – First serve		
AGE LIMITS	 Senior (FIG): gymnasts born in 1998 and before 15-16: gymnasts born in 1999 and 2000. 13-14: gymnasts born in 2001 and 2002. 11-12: gymnasts born in 2003 and 2004. All gymnasts must have a current valid FIG license. 		
EVENT FORMAT	 Trampoline Individual Men; Trampoline Individual Women; Trampoline Synchro Men; Trampoline Synchro Women; Double Mini-trampoline Men; Double Mini-trampoline Women Tumbling Men; Tumbling Women. 		
JUDGES AND JURIES	The number of Judges' panels will be decided by the organizing Member Federation depending on the number of participating competitors and judges. The Judges' Panels will be set up by a draw from the judges present at the event. Each participating federation must provide minimum one judge (minimum category IV) per discipline in which they participate. All judges must have a current valid FIG brevet.

ENTRY FEES	The cost for the entry fee is EUR 40.00 per gymnast.		
	The Invited Participating Federations must pay for all entry fees. Entry fees should be wired to the account listed within this document. Entries without payment of the entry fees will be considered as invalid and will be refused.		
ACCOMMODATION	Please, note that the beginning of June is the hot touristic season in St.Petersburg and all hotels increase prices sufficiently.

The request must include a copy of the first page of passport, the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.			
INSURANCE	The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations (Section 1, Article 12.10) foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the Members of their Delegation. The Organizing Committee will verify the insurance upon arrival of the Delegation Members (e.g. cover note or photocopy of the valid policy).
