DRAWING OF LOTS	The gymnasts' drawing of lots will take place in St.Petersburg by the Organizing Committee one week before competitions start.
ENTRY FEES	<p>The cost for the entry fee is EUR 40.00 per gymnast.</p> <p>The Invited Participating Federations must pay for all entry fees. Entry fees should be wired to the account listed within this document.</p> <p>Entries without payment of the entry fees will be considered as invalid and will be refused.</p>
ACCOMMODATION	<p>Please, note that the beginning of June is the hot touristic season in St.Petersburg and all hotels increase prices sufficiently.</p> <p>The Organizing Committee has reserved allocations for official delegations in the following hotels:</p> <p>Radisson Sonya Hotel Liteiny prospect 5/19, St. Petersburg</p> <p>The costs per room/night in this first hotel are as follows: 150 Euro - single room, including breakfast 190 Euro - double room, including breakfast</p> <p>Hotel MOSKVA Ploschad Alexandra Nevskogo, 2</p> <p>The costs per room/night in this hotel are as follows: 130 Euro - single room, including breakfast 140 Euro - double room, including breakfast</p> <p>The prices charged for the hotel rooms will not exceed the usual hotel rates. While the Accommodation Form must be returned to the OC by 8th April 2015 at the very latest, the Hotel rooms will be allocated on a "first come, first serve" basis.</p> <p>The invited participating federations must pay for their accommodation costs. At the time of the Definitive registration (2 months prior to the event) 50% of the accommodation costs must be paid to the OC. Entries without the payment of the 50% of the accommodation costs will be considered as invalid and will be refused. The remaining 50% of the accommodation costs must be paid by 6th May 2015.</p> <p><u>If anyone is interested in staying in a hostel for a lower price (without transportation and meals) please contact the OC.</u></p>
MEALS	<p>The invited participating federations must pay for the meals expenses of their delegation members.</p> <p>While the Meals Form must be returned to the LOC 8th April 2015 at the very latest, the costs for the meals must be paid to the LOC by 6th May 2015.</p> <p>Cost of each meal per person acquired on accreditation (Lunch and Dinner) – € 15,00.</p>
FINAL BANQUET	<p>All participants are invited to participate in the Final Banquet.</p> <p>Final Banquet is free of charge for the Delegations, which booked their accommodation through the Organizing Committee. For all others ticket cost for Final Banquet is EUR 40.</p>

VISA	Please verify immediately with your travel agent or the Russian Embassy or Consulate in your country if a visa is required for your travel to Russia. The Organizing Committee will be happy to assist each Delegation Member with an official invitation letter, provided that the request is made before May 6th, 2015 to the Organizing Committee. The request must include a copy of the first page of passport, the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.												
INSURANCE	The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations (Section 1, Article 12.10) foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the Members of their Delegation. The Organizing Committee will verify the insurance upon arrival of the Delegation Members (e.g. cover note or photocopy of the valid policy). Delegation Members with insufficient insurance cover must inform the Organizing Committee in advance.												
ACCREDITATION	<p>Delegation accreditation will take place upon arrival. For accreditation, Heads of the Delegations are required to bring the following documents:</p> <ul style="list-style-type: none"> • Passports of all members of the delegation; • Proof of total payments; • Proof of medical insurances; • CD of their National Anthem and National Flag; <p>All financial obligations must be fulfilled before arrival or during the accreditation.</p> <p>Accreditation card is personal for each of the delegation members. Accreditation card wearing is required at all times of the tournament.</p> <p>NOTE: <i>The Organizing Committee will be responsible for checking the validity of the gymnast' Licenses. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.</i></p>
