<b>EVENT FORMAT</b>	<p>The event will be organized as an individual all-around-competition (no qualification) in women's artistic gymnastics.</p> <p>A maximum of 32 gymnasts are allowed to participate; allocation in order of entry (first come – first serve). All gymnasts compete in the all-around-competition.</p> <p>Each Federation or Club <u>can</u> nominate a team (consisting of 3 gymnasts; 2 juniors, 1 senior). A maximum of 8 teams is allowed.</p> <p>The LOC can build international mixed teams.</p> <p>The best 2 results of each apparatus generate the team result.</p>

<b>INSURANCE</b>	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p>
