FEDERATIONS INVITED	The Organizing Member Federation will invite all Member Federations from the South American Gymnastics Confederation: ARG, BOL, BRA, CHI, COL, ECU, PAN, PAR, PER, URU, VEN.
AGE LIMITS	<ul style="list-style-type: none">• Senior TRA All gymnasts must have a current valid FIG and CONSUGI licence until the end of the event.
JUDGES AND JURIES	The number of Judges' panels may be decided by the Local LOC and the Superior Jury of the event depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw – directed by the Superior Jury – from the judges present at the event. Each participating federation must provide minimum two judges (minimum category IV). Failure to do so will result in a fine of 1000 U\$S to be paid to the

	organizing member federation in order to cover the expenses of inviting an additional judge to the event. All judges must have a current valid FIG brevet at the time of the event.

ENTRY FEES	The cost for the entry fee is U\$S 25 per gymnast.. The participating federations must pay for all entry fees. At the time of the Definitive registration (2 months prior to the event) 100% of the entry fee must be paid to the LOC. The entry fee is not refundable. Entries without payment of the entry fees will be considered as invalid and will be refused.						
ACCREDITATION	At the time of arrival, every delegation will receive a welcome package including all relevant information and the accreditations, which will allow access into the training and competition halls. The accreditation is personal and non-transferable and must be used at all times. In case of loss, the Head of Competition must be contacted immediately. The accreditations will only be handed out to the head of delegation. All delegations must deliver national anthem, flag, insurance, passports of all members, FIG Card Licence and CONSUGI Card Licence.						
EVENT FORMAT	<p>This South American Championship will be run in the following discipline for seniors:</p> <ul style="list-style-type: none">• Individual Trampoline• Synchronized Trampoline <p>Competition will consist of Qualifications and Finals.</p> <p>Participation in the Qualifications:</p> <ul style="list-style-type: none">• All competitors must take part in the qualifications.• No qualifications must be held if there are less than 9 participants per discipline.• In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2017 FIG Technical Regulations) shall be applied. <p>Participation in the Finals:</p> <ul style="list-style-type: none">• The top eight gymnasts or pairs from the qualifications qualify for the finals.• There will be no limits of participants per federation in the finals.• In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2017 FIG Technical Regulations) shall be applied.

VISA	<p>Please verify immediately with your travel agent or the Colombian Embassy or Consulate in your country if a visa is required for your travel to Colombia. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before August 14th to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The LOC will subsequently offer insurance at the Federations own charge as follows: USD 25 per person.</p>
INTERNATIONAL TRANSPORTATION	<p>The participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by August 14th, 2017</p>
LOCAL TRANSPORTATION	<p>Delegations booking accommodation through the LOC will be free offered transport:</p> <ul style="list-style-type: none"> - From El Dorado Airport (IATA Code: BOG) to the competition venue or hotel and back provided notifications of flights details has given prior August 14th 2017 - From Hotel to the competition venue

CANCELATION POLICY	<p>Rooms with or without full board cancelled until August 14th 2017 at the very latest will be subject to a cancellation fee of 0%.</p> <p>Rooms with or without full board cancelled from August 15th of 2017 until September 01st of 2017 at the very latest will be subject to a cancellation fee of 50% to be paid by the Federation concerned.</p> <p>Rooms with or without full board cancelled from September 02nd, 2017 until the arrival of the delegations on site or "no show" will be subject to a cancellation fee of 100% to be paid by the Federation concerned.</p>
