AGE LIMITS	<b>SENIORS:</b> 18 years old in the year of the competition.  <b>AGE GROUP 2:</b> 15–17 years old in the year of the competition.  <b>AGE GROUP 1:</b> 12–14 years old in the year of the competition.  <b>All gymnasts need to have a valid FIG license until the end of the event</b>  A competitor can compete in maximum 3 Aerobic categories in accordance with current Technical Regulations Reg. 4.4 pt 6, Section 1.									
JUDGES AND JURIES	Every Federation must send 1 judge with a valid FIG Brevet of the current cycle, for all the competition. To be able to count with the proper number of qualified judges in the competition, we invite the participating countries to attend the competition with 2 judges.  The judges panel must have a minimum of: 4 Artistic Judges 4 Execution Judges 2 Difficulty Judges 1 Chair of Judges Panel  <b>All judges must have a current valid FIG brevet at the time of the event.</b>

<b>PARTICIPATION</b>	<p>The number of participants by nation, category and age group is not limited.</p> <p>All AG1 (12-14 Years), AG2 (15-17 years) and Seniors gymnasts in good standing with the correct age and holding a valid FIG license until the end of the event, may participate.</p> <p>1 Head of Delegation and 3 coaches are allowed per nation.</p> <p>The cost per additional person (Coaches, Team leaders, Doctors, Physiatrists and guests) will be of <u>\$ 100.00 USD</u> each, which grants them, the same rights granted to the members of the delegation.</p>
<b>ACCREDITATION</b>	<p>During Accreditation, Heads of Delegation must present the following:</p> <ul style="list-style-type: none"> <li>• Passports of every member of their delegation.</li> <li>• Medical insurances of each member of their delegation. (Coaches and Head of Delegations also)</li> <li>• Musics in MP3 Format with correct identification of athletes: <b>PER_Senior_IW_PEREZ_JUANA</b></li> <li>• 1 CD per routine</li> <li>• National Anthem.</li> <li>• National Flag</li> <li>• Difficulty Elements List for every routine.</li> <li>• FIG License.</li> </ul> <p>There will be an Access control in each area. The participants must wear their accreditation cards inside each area.</p>

<b>VISA</b>	<p>Please verify immediately with your travel agent or the Peruvian Embassy or Consulate in your country if a visa is required for your travel to Lima - Perú. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter only if the request is made before June 23<sup>rd</sup>, 2017.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>
<b>INSURANCE</b>	<p>It is required that the Heads of Delegation present a medical insurance of every member of their delegation; otherwise, they will have to pay a medical insurance when they arrive, for the days of training and competition, whose cost is 45 USD per person.</p>

	<p>The Host Federation, the Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations (Section 1, Article 12.10) foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the Members of their Delegation.</p> <p>The LOC will verify the insurance upon the arrival of the members of each delegation (for example: the original and photocopy of the valid insurance policy). The Peruvian Federation of Gymnastics declines all responsibility in case of illness, accidents, and repatriation. Every participant must be insured against these risks.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by <b>July 21<sup>st</sup> 2017</b></p>
<b>LOCAL TRANSPORTATION</b>	<p><b>The LOC will provide ground transportation to the delegations from the International Airport of Lima to the Official Hotels with and additional cost of <u>USD20.00</u> per way per person. The Travel Schedule Form must be returned to the LOC by July 21<sup>st</sup> 2017</b></p> <p>The LOC will provide ground transportation from the hotel to the Gymnasium and vice versa for the days of training and competition.</p>

For those delegations which do not book their hotel accommodation through the LOC, the LOC will not be responsible for the local transportation.</p> <p>All the rates of the hotels are per night, per person. The rates are in USD and include the 3 meals.</p> <p>When the Definitive Registration is sent, the 50% of the costs of hotel accommodation and meals must be paid to the LOC. The remaining 50% of the payment must be paid when the Nominative Registration is sent. No Reimbursements for cancellations will be given.</p> <p>The invited participating federations must pay for the accommodation expenses of their delegation members.</p>
<b>AWARDS</b>	<p>Medals will be given to the first three places in each Age Categories, and in each of the discipline. Certificate of participation will be awarded to all competitors and officials. No prize money will be given.</p>
<b>RULES OF COMPETITION</b>	<p>The competition consists of a Qualifying Round and a Final Round.</p> <p>There will be qualifications only for the categories with 9 or more participants.</p>

	<p>The top 8 gymnasts per category and age group will qualify for the Finals. In case of a tie in any place, the tie-breaking rules are as set by FIG.</p> <p>Final: Eight (8) gymnasts per category of the Qualifying Round will pass to the finals (Maximum, 2 per category, per country). If the organizing Federation has not qualified in any category, it will be able to appoint one participation, maximum: 1 per category, of its choice. Therefore, the Maximum Participation in the final phase is 8 + 1 in one category and 8 in the other categories.</p> <p>The participant with the Wild Card must have participated in the respective qualifying categories, and he or she will be able to receive medals.</p>

Example: If a gymnast is competing in IW in South American Championship, she/he can participate in Copa Peru in other categories like MP, TR, GR, AD, AS but not in IW.</p>
