<b>JUDGES AND JURIES</b>	<p><b>Jury of Appeal:</b> Katia Lemos: President of CONSUGI Aerobic Gymnastics Technical Committee.</p> <p><b>Judges:</b> Every Federation must send, at least, 1 judge with a valid FIG Brevet of the current cycle, for all the competition. In order to be able to count with the proper number of qualified judges in the competition, we invite the participating countries to attend the competition with more judges than the required ones in the invitation, without limit of judges per country.</p> <p>Those federations which do not send minimum 1 judge will have to pay the amount of \$1,000.00 USD in order to cover the expenses of an invited judge. This must be informed to CONSUGI and the Local Organizers when the nominative registration is sent.</p> <p>The judges panel must have a minimum of: 3 Artistic Judges 3 Execution Judges 2 Difficulty Judges 1 Chair of Judges Panel</p> <p>The CONSUGI Representative will act as Superior Jury. All judges must have a current valid FIG brevet at the time of the event.</p>

## VISA

Please verify immediately with your travel agent or the Peruvian Embassy or Consulate in your country if a visa is required for your travel to Lima - Perú. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before July 18<sup>th</sup>, 2015 to the LOC.

The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.

## INSURANCE

It is required that the Heads of Delegation present a medical insurance of every member of their delegation; otherwise, they will have to pay a medical insurance when they arrive, for the days of training and competition, whose cost is 35 USD per person.

The Host Federation, the LOC, the CONSUGI and the FIG will not be held

	<p>responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p> <p>The Peruvian Federation of Gymnastics declines all responsibility in case of illness, accidents, and repatriation. Every participant must be insured against these risks.</p>
<b>INTERNATIONAL TRANSPORTATION</b>	<p>The invited participating federations must pay for the travel costs of their delegation members.</p> <p>The Travel Schedule Form must be returned to the LOC by July 18th, 2015.</p>
<b>LOCAL TRANSPORTATION</b>	<p>The LOC will provide ground transportation to the delegations from the International Airport of Lima to the Official Hotel and vice versa only if they arrive and depart on the date stipulated. (Arrival Tuesday 25<sup>th</sup>, Departure August 30<sup>th</sup>). There will be ground transportation from the hotel to the Gymnasium.</p> <p>If Delegations do not arrive or leave on the dates stipulated, The LOC can help arranging the transportation with a additional payment of USD20.00 per person per way. This must be paid at the moment of the registration.</p>
<b>ACCOMMODATION</b>	<p>The hotel accommodation and meals will be in Hotel Maria Angola. The rate per person per night will be USD70.00 in double or triple room.</p> <p>The booking must be done through the LOC. For those delegations which do not book their hotel accommodation through the LOC, the LOC will not be responsible for the local transportation (Airport – Hotel – Airport). All the rates of the hotels are per night, per person. The rates are in USD and include the 3 meals, in double or triple occupancy.</p> <p>When the Definitive Registration is sent, the 50% of the costs of hotel accommodation and meals must be paid to the LOC. The remaining 50% of the payment must be paid when the Nominative Registration is sent. While the Accommodation Form must be returned to the LOC by July 18<sup>th</sup>, 2015. At the very latest, the Hotel rooms will be allocated on a “first come, first serve” basis.</p> <p>The invited participating federations must pay for the accommodation expenses of their delegation members.</p> <p>The rate of USD70.00 will only be considered from August 24<sup>th</sup> to August 30<sup>th</sup>. <b>AWARDS</b>	<p>SENIORS and AGE GROUPS will receive a 1st Place Medal, a 2nd Place Medal and a 3rd Place Medal. No prize money will be given.</p>

A trophy will be delivered, in each one of the divisions (Adults, Age Group I and Age Group II), for the federation which obtains the greatest number in the sum of the 4 final highest scores, of the 4 different categories: IM, IW, MP, TR, GR, AERO-DANCE (Only for Seniors) and AERO-STEP (Only for Seniors).

**RULES OF COMPETITION**

The competition of the South- American Championship consists of a Qualifying Round and a Final Round in every category and age group.

Qualifying Round: A maximum of 4 athletes per category and age group, per country.

Final: Eight (8) gymnasts per category of the Qualifying Round will pass to the finals (Maximum, 2 per category, per country). If the organizing Federation has not qualified in any category, it will be able to appoint one participation, maximum: 1 per category, of its choice. Therefore, the Maximum Participation in the final phase is 8 + 1 in one category and 8 in the other 4 categories.

The participant with the Wild Card must have participated in the respective qualifying categories, and he or she will be able to receive medals.
