FEDERATIONS INVITED	The Organizing Member Federation will invite all Member Federations from the South American Gymnastics Confederation: ARG, BOL, BRA, CHI, COL, ECU, PAN, PAR, PER, URU, VEN.		
AGE LIMITS	 Senior TRA Junior TRA All gymnasts must have a current valid FIG and CONSUGI licence until the end of the event. 		
JUDGES AND JURIES	The number of Judges' panels may be decided by the Local LOC and the Superior Jury of the event depending on the number of participating competitors and judges. The Judges' panels will be set up by a draw – directed by the Superior Jury – from the judges present at the event.		

	Each participating federation must provide minimum two judges (minimum category IV). Failure to do so will result in a fine of 1000 U\$S to be paid to the organizing member federation in order to cover the expenses of inviting an additional judge to the event.
REGISTRATION DEADLINES	All judges must have a current valid FIG brevet at the time of the event. Definitive and Nominative registrations must be completed by sending the composition of the delegation via email to: caro.corradi@gmail.com , samir_portillo@hotmail.com and fedecolg@yahoo.com Definitive registration: 03 rd October, 2016 (2 month prior the event) Nominative registration 03 rd November, 2016 (1 month prior the event)
ENTRY FEES	The cost for the entry fee is U\$S 25 per gymnast The participating federations must pay for all entry fees. At the time of the Definitive registration (2 months prior to the event) 100% of the entry fee must be paid to the LOC. The entry fee is not refundable. Entries without payment of the entry fees will be considered as invalid and will be refused.
ACCREDITATION	All delegations will be guided to the hall (accreditation desk) upon arrival to Bogotá. The accreditation will take place at the venue upon arrival. The accreditations will only be handed out to the head of delegation. All delegations must deliver national anthem, flag, insurance, passports of all members, FIG Card Licence and CONSUGI Card Licence.
EVENT FORMAT	This South American Championship will be run in the following two (2) disciplines and two (2) levels: Individual Trampoline Synchronized Trampoline Competition will consist of Qualifications and Finals. Participation in the Qualifications: All competitors must take part in the qualifications. No qualifications must be held if there are less than 9 participants per discipline. In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2016 FIG Technical Regulation) shall be applied. Participation in the Finals: The top eight gymnasts or pairs from the qualifications qualify for the finals. There will be no limits of participants per federation in the finals. In case of a tie at any place, the tie-breaking rules as set up for the World Championships (see 2016 FIG Technical Regulation) shall be applied.
