The UEG Accreditation Rules will be strictly applied, notably as far as the number of accreditations per federations is concerned. No further accreditations may be issued (for changes after the on-line nominative registration, please see the "Request for Accreditation Changes" form - Appendix X, that will be included to the Work Plan). Any additional person is considered as a spectator and must buy entry tickets. Accreditations will not be delivered unless all financial and insurance obligations have been done.

At the time of the Nominative Registration (March 18th 2015) all fees must be paid to the LOC.

Each delegation will be taken to the accreditation desk upon arrival. The following items will be checked there:

- Passports of gymnasts
- License of the gymnast
- Passports of judges and professional card of medical persons
- National anthem and national flag
- WAG Music for floor exercise
- Transport Departure
- Insurance every delegation member needs a valid insurance
- Total payment of accommodation and meals
- Accreditation badge

ONLINE ACCREDITATION

Together with the Nominative registration and to accelerate the process of the accreditation each delegation is kindly asked to fill in the online Form using the following address before **March 18**th 2015 (11:59 pm).

Each member of the delegation (Head of delegation, Team leader, judges, coaches, gymnasts, medical staff, accompanying person...) must be registered. The form must be filled-in and completed with a passport photo Color photo,

File format: .jpg or .jpeg,

350 mm x 450mm or 276 pixels x 354 pixels (width X height).

For gymnasts and judges a copy of valid passport (format JPG or PDF) is to be added.

The online system will be open **from 15**th **January** (08:00 am) and will be closed **on March 18**th, by 24:00 (GMT time).



If the form has not been filled in correctly or if the photo has to be taken at the accreditation because none has been sent within the deadline or not sent in the official requested format, there will be a charge of 15

euros for each photo taken at the accreditation desk.

NB: If you have any problem to upload the photo and in order to facilitate the accreditation process, the national federations are requested to send to the LOC (<u>organisation@francepromogym.com</u>), the photo of all delegation's members until **March 27, 2015** (passport photos in .jpg or .jpeg format, dimension 350mm **X 450mm**, or 276 pixels x 354 pixels (width X height), File name: NOC_SURNAME_Firstname (e.g. FRA_PARIS_Clara.jpg).

WAG FLOOR MUSIC

In order to simplify the management of the music and to limit the technical problems of wiring for sound during the competitions, the Organizing Committee wishes to reduce the variety of the musical supports (CD, USB stick) and to use the numerical support only.

All the music (mp3, mp4, wav format) and music release used during the 6th Women's Artistic Gymnastics European Championships must be submitted online by this **FORM** until **March 18th 2015.**

By sending this form you:

- approve the technical criteria for playing the musics by the organiser;
- guarantee and as a discharge indicate that the pieces of music chosen are not forbidden to be played, including during a sports event.

Without information, at the accreditation, the Heads of delegation have to hand in the Music Release form (App. X)

Each music file will have to contain the following information:

- The name of the nation (official abbreviation of the country);
- The first and last name of the gymnast;

NB: Keep in your possession a specimen of your CD for your training sessions and in case of a technical problem in the Competition area.

EVENT FORMAT

MAG competition (CI):

Each National Federation can enter a maximum of 6 MAG gymnasts A maximum number of 4 MAG gymnasts per apparatus are allowed

WAG competition (CI):

Each National Federation can enter a maximum of 4 WAG gymnasts All 4 WAG gymnasts per apparatus are allowed

MAG-WAG competition (CII):

The 24 gymnasts with the highest ranking obtained in the qualifying competition CI will qualify for the individual all-around final C II.

A maximum of 2 gymnasts per National Federation are allowed in this final. 4 reserve gymnasts will be determinate.

MAG-WAG competition (CIII):

Friday, April 17th

The 8 highest ranked gymnasts in the qualifying competition C I per apparatus will qualify for the apparatus finals C III.

A maximum of 2 gymnasts per National Federation are allowed in these finals. 3 reserve gymnasts will be determinate for each final
