ACCREDITATION	The accreditation will take place at the Jonava Sport Arena. Delegations accreditation will take place upon arrival. For accreditation the head of delegation is required to bring the following documents: -passports of all members of the delegation -proof of medical insurance of all members of the delegation -CD with music for the programs (2 copies of each routine+1 copy keep for training) - difficulty elements list for each routine -all delegations must deliver its flag		
COMPETITION FORMAT	Each competitor can participate in max 3 categories. Qualifications and finals will be carried out in each of the 5 categories (IM, IW, MP, TR and GR) The 8 best scores per category (max. 1 per federation for GR, resp. 2 for Individual Men, Individual Women, Mixed Pairs and Trios) may participate in the finals.
