Guidelines for Competition Forms

Dear NOCs

We have the pleasure to inform you that a set of competition forms for will be available to collect at the NOCs first visit to the Sports Information Desk (SID) located at the Youth Olympic Village (YOY).

Artistic Gymnastics

Music

The Music Form has been sent by the IOC to the NOCs. While the WAG gymnasts' Music Form must be submitted duly completed to FIG Offices at the latest on 1 August 2014, the WAG gymnasts' floor exercise music must be submitted to the SID-YOV by the deadlines set out in the table below.

All NOCs are required to hand two copies of their gymnast's music into the SID-YOV. The two CDs should be labelled with the gymnast's name, the NOC, the title of the music, the length of the music, and the name(s) of the music composer(s).

In addition, gymnasts should bring their own copies of their floor music on CD to use during their training sessions.

It is the responsibility of each NOC to ensure that gymnasts listen to their music during podium training and sign to confirm that they are happy with the recording.

The gymnasts' music will be available for collection from the SID-YOV once their participation in the event has come to an end. Any CDs that have not been collected by 24h00 on 28 August 2014 will be recycled.

Confirmation of Participation for Qualification

For the Qualifications, the confirmation of participation of the gymnasts must be submitted to the SID-YOV by the deadlines outlined below.

Confirmation of Withdrawal for Finals

NOCs are not required to confirm participation in CII or CIII, but instead must inform the SID-YOV if they wish to reject their place and therefore withdraw their gymnast. This applies to the named reserve gymnasts for each apparatus final (CIII) and the named reserve gymnasts for the All-Around Final (CII). Confirmation to withdraw a gymnast must be submitted to the SID-YOV by the deadline outlined below.

WAG written exercises (submission)

NOCs wishing to submit written exercises (shorthand writing) of their female gymnast should do so as soon as possible on arrival at the SID-YOV from 12 August 2014 and no later than 20h00 on 13 August 2014.

New elements and vault numbers

Each NOC must submit new elements and vault numbers to the location and by the deadlines set out in the table below, from where they will be placed in the MAG Superior Jury or WAG Superior Jury box.

Request to change apparatus measurements

Each NOC must submit a request to change apparatus measurements at the SID-YOV by the deadline set out below, from where it will be placed in the MAG Superior Jury or WAG Superior Jury box.

Inquiry

Inquiry forms will be included in the set of competition forms to be collected by each NOC at their first visit to the SID-YOV.

Trampoline Gymnastics

Confirmation of Participation for Qualification

For the Qualifications, the confirmation of participation of the gymnasts must be submitted to the SID-YOV by 13h30 on 20 August 2014 for the women and by 13h30 on 21 August 2014 for the men.

Confirmation of Withdrawal for Finals

NOCs are not required to confirm participation in the Finals, but instead must inform the President of the Superior Jury if they wish to reject their place and therefore withdraw their gymnast. This applies to the named reserve gymnasts as well.

Inquiry

Inquiry forms will be included in the set of competition forms to be collected by each NOC at their first visit to the SID-YOV.

Competition Cards (Difficulty)

The official Competition Cards must be prepared for each phase of competitions (qualifications and finals) of each individual gymnast. Completed Competition Cards should be handed into the SID - YOY by 20 August 2014.

Rhythmic Gymnastics

Music

The Music Form has been sent by the IOC to the NOCs. While the gymnasts/groups' Music Form must be submitted duly completed to FIG Offices at the latest on 1 August 2014, the gymnasts/groups' floor exercise music must be submitted to the SID-YOV by 23 August 2014.

All NOCs are required to provide two copies of the music for each routine into the SID-YOV. A different CD should be used for each exercise. The music must be recorded at the beginning of the CD. The following will be marked on the CD:

- The name of the individual gymnast and her NOC / The three capital letters used by the NOC to designate the group.
- A symbol representing the apparatus used.
- The length of the music.
- The name(s) of the composer(s) of the music used.
- The title of the music used.

In addition, gymnasts/groups should bring their own copies of their music on CD to use during their training sessions.

It is the responsibility of each NOC to ensure that gymnasts/groups listen to their music during podium training and sign to confirm that they are happy with the recording.

The gymnasts'/groups' music will be available for collection from the SID-YOV once their participation in the event has come to an end. Any CDs that have not been collected by 24h00 on 28 August 2014 will be recycled.

Confirmation of Participation for Qualification

For the Qualifications, the confirmation of participation must be submitted to the SID-YOV for the individual gymnasts by 11h00 on 25 August 2014 and for the groups by 19h00 on 25 August 2014.

Confirmation of Withdrawal for Finals

NOCs are not required to confirm participation in the Finals, but instead must inform the SID-YOV if they wish to reject their place and therefore withdraw their gymnast/group. This applies to the named reserve gymnast/group as well. Confirmation to withdraw for the individual gymnasts and the groups must be submitted to the SID-YOV by 10h00 on 27 August 2014

Inquiry

Inquiry forms will be included in the set of competition forms to be collected by each NOC at their first visit to the SID-YOV.

Difficulty forms

The official Difficulty Forms must be prepared on the computer for each exercise of each individual gymnast and group. Completed Difficulty Forms should be handed into the SID - YOV by 23 August 2014.
