




CANCELLATION POLICY

Cancellations until July 18, 2017 are subject to a cancellation fee of 0%
Cancellations from July 19 to August 18, 2017 are subject to a 50% cancellation to be paid by the federation in question. Therefore, they will not be refunded of their deposits.

Cancellations from 19 August to 30 August 2017 are subject to a cancellation fee of 75% to be paid by the federation concerned.

Cancellations from August 31, 2017 to the day of arrival of the delegations or by "no show" are subject to a 100% cancellation fee payable by the federation in question.
