The Technical Delegate, accompanied by the Technician of the Apparatus Manufacturer will proceed to the apparatus control in the competition hall, warm-up hall and training hall(s) prior to training and competition.

The Apparatus control includes the check of the dimensions of the RG competition floors which must respect the valid FIG Apparatus Norms. All floors must be set up correctly and the RG competition floors in the different halls must be identical.

Final Group Routines:

The top eight (8) groups of each Group Routines will qualify for the Finals.

FEDERATIONS INVITED

All FIG Member Federations in good standing are invited.

SIZE OF DELEGATION AND FIG LICENSE

Only senior gymnasts in good standing with the correct age and holding a valid FIG License at the time of registration until the end of the competitions may participate. No gymnasts will be accepted without a valid FIG License at the deadline of the Nominative Registration.

AGE LIMITS

16 years in the year of the competition

JUDGES AND JUDGES' PANELS

Competitions will be evaluated by two Judges' Panels as follows:

- 4 Difficulty (D) Judges (min. cat. 2)
- 6 Execution (E) Judges (min. cat. 3)
- 2 Line (L) and 1 Time (T) Judges (min. cat. 4)

Priority will be given to the highest categories.

Not more than one judge per Federation per panel will be permitted except for Time and Line Judges.

The Judges' Panels are set up by a draw from the judges present at the event. The draw will be directed by the RG Technical Delegate.

The participating member federations must send minimum one qualified judge if they participate with individual gymnasts and one qualified judge if they participate with a group.

The Organizing Member Federation is responsible that there is enough FIG brevetted judges present with the appropriate valid category of brevet for their function. Should there not be sufficient judges as per the on-line nominative registration, or not sufficient cat. 1 and 2 judges, the Organizing Member Federation must propose to the FIG for prior approval of the Technical Delegate the name of neutral additional judges to complete the panels (plus 2 reserves). These judges, once approved, have to be invited at the cost of the Organizing Member Federation.

FIG TECHNICAL DELEGATE FREGISTRATION	Such invitation must be made through the respective Member Federation. Should the Organizing Member Federation fail to propose names for additional judges, the FIG Office in consultation with the Technical Delegate concerned will invite these judges at the cost of the Organizing Member Federation. The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC by 28 February 2018) should a federation fail to bring the required number of judges or judges without the requested qualification (brevet). The FIG Technical Delegate will be proposed by the FIG RG TC. He/she will serve as President of the Superior Jury. The Organizing member Federation shall determine the hotel at its discretion, but may not chose the "low cost" category hotel for the above mentioned gymnasts.

The costs for the accommodations must be paid to the LOC by **28 February 2018** as follows: 100% (by the deadline for the Nominative registration).

While the Accommodation Form must be returned to the LOC by 29 January 2018 at the very latest, the Hotel rooms will be allocated on a "first come, first serve" basis. The LOC reserves the right to propose some of the other above-mentioned hotels in case the hotel of the federations' first choice is fully booked.

Cancellation/Reimbursement Policy:

50% of Accommodation cost shall be reimbursed if the cancelation occurs up to 1 month prior to the event. After, no reimbursement will be made.

MEALS

The invited participating federations must pay for the meals expenses of their delegation members, except for the below mentioned gymnasts for whom meals will be paid by the LOC (from the official arrival day to the official departure day): The top three (3) gymnasts in the All-Around ranking from the previous 2017 World Championships present at the event The top three (3) Groups in the All-Around ranking from the previous 2017 World Championships present at the event The Meals Form must be returned to the LOC by 29 January 2018 at the very latest and 100% of the costs for the meals must be paid to the LOC by 28 February 2018. **Cancellation/Reimbursement Policy:** 50% of the meals cost shall be reimbursed if the cancelation occurs up to 1 month prior to the event. After, no reimbursement will be made. FINAL BANQUET The Local Organizing Committee is pleased to organize in the evening of 1st April 2018 a free of charge final banquet for all accredited members in the delegations. The invited participating federations must pay for the International travel costs of their **INTERNATIONAL** delegation members. **TRANSPORTATION** The Travel Schedule Form must be returned to the LOC (bulrg@abv.bg) by 09 March 2018 at latest. The LOC will provide local transportation (i.e. from/to the airport, railway station and/or LOCAL bus station as well as from/to the hotel and the Competition, Training, and Warm-up **TRANSPORTATION** Halls and from/to any other official activity) for the period from 28 March (arrival day) to 02 April 2018 (departure day) inclusive for the delegation members who book their accommodation through LOC. The cost for the local transportation are included in the accommodation price. **VISA** Please verify immediately with your travel agent or the Bulgarian Embassy or Consulate in your country if a visa is required for your travel to Bulgaria. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before 28 February 2018 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to. In order to avoid the risk of no visa issuing because of late requests the LOC recommends to the participating federations to send extended lists of participants by the above mentioned deadline. Bulgaria applies a visa-free system for holders of valid Schengen visas. The Host Federation, the LOC and the FIG will not be held responsible for any liabilities **INSURANCE** in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy).

Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 20 EUR per person.

ACCREDITATION

FINANCIAL OBLIGATIONS

Federations which have not fulfilled their financial obligations towards the FIG (e.g. annual membership fees, unpaid invoices, etc.) will not be allowed to participate in this World Cup.

Federations which have not fulfilled their financial obligations towards the LOC by the given deadline in the Invitation/Directives may still have the possibility to participate, but the LOC will not guarantee the hotel booking, meals and local transportation.

Federations which have not fulfilled their financial obligations towards the Organizing Member federations upon arrival will not be accredited.

TIE BREAKING RULES

In case of a tie at any place, the tie breaking rules for the RG World Championships as outlined in the current FIG Technical Regulation Section 3 shall be applied.

After application of the tie breaking rules outlined in the current FIG Technical Regulation Section 3, if there is still a tie:

For participation to the Apparatus Final (Individual) and Final Routine (Group):

• If there is still a tie, the tied gymnasts / groups will proceed to the final

For Prize money:

 The prize money of the tied ranks will be added and divided by the number of ties.

For World Cup Points:

 The World Cup points of the tied ranks will be added and divided by the number of ties.

For Yearly winner (Rules for the RG FIG World Cup Series 2017,2018, 2018, 2020):

- The number of ranks of the three counting competitions achieved by the respective gymnast/group will be added and the gymnast/group with the lowest total will prevail.
- If there is still a tie, the total score of the three counting exercises will be added and the gymnast/group with the highest total will prevail.
- If there is still a tie, the total execution score of the three counting exercises will be added and the gymnast/group with the highest total execution score will prevail

PRIZE MONEY
