The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before March 02 nd 2016 to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.
INSURANCE	The Host Federation, the Local Organizing Committee and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating

	Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy in english writing). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge as follows: 35,00 EUR per person/day.			
ACCREDITATION	The accreditation will take place at the Pavilhão do Marialvas upon arrival to Cantanhede city. The accreditations will only be handed out to the Head of Delegation. All delegations must deliver 2 music CD's for each routine, difficulty elements list for each routine, national anthem and flag, insurance declaration, passports of all members and FIG License Card Check.			
FINANCIAL OBLIGATIONS	Federations which have not fulfilled their financial obligations towards the FIG (e.g. annual membership fees, unpaid invoices, etc.) will not be allowed to participate in these Competitions.
