<b>AGE LIMITS</b>	Junior: 13-15 year old (born 2005-2004-2003) Senior: from 16 year old (born 2002 and earlier)
<b>DELEGATION SIZE</b>	1 judge (FIG Brevet min. IV) 1 coach 4 gymnasts (maximum 2 per age category) <b>All gymnasts must have a current valid FIG license at the time of the event.</b>

<b>JUDGES AND JURIES</b>	<p>All judges must have a current valid FIG brevet at the time of the event for the respective discipline (RGI and/RGG).</p> <p>For delegations not presenting FIG brevet judge a tax of 200€ will be applied.</p>

For accreditation you must present:</p> <ul style="list-style-type: none"> <li>▪ 2 CD's for each gymnast's music</li> <li>▪ payment of accomodation and entry fee</li> <li>▪ FIG license for gymnasts</li> </ul> <p>Payment for accomodation+meals and participation fee to be paid in cash, during accreditation, or by bank transfer, before arrival.</p>															
<b>EVENT FORMAT</b>	<ul style="list-style-type: none"> <li>• Individual All-around (4 routines)</li> <li>• Team competition (JUNIOR) – 2 gymnasts/8 routines</li> <li>• Finals per apparatus - JUNIOR and SENIOR gymnasts (8 best gymnasts, maximum 2 per team/3 per country). The organizing association has the right to add 1 gymnast to each final.</li> </ul>															
<b>PROVISIONAL SCHEDULE</b>	<p><b>12 April:</b> Arrival of the delegations</p> <p><b>13 April:</b> Official trainings / Judges meeting / City sightseeing</p> <p><b>14 April:</b> All-around competition</p> <p><b>15 April:</b> Finals per apparatus</p> <p><b>16 April:</b> Departure of the delegations</p>															
<b>AWARDS</b>	<p><b>ALL-AROUND COMPETITION:</b> First 3 classified gymnasts in each age category will be awarded cups, medals, diplomas and prizes. The coach of the winner gymnast in each category will be awarded diploma and prize.</p> <p><b>TEAM COMPETITION (JUNIOR):</b> First 3 classified teams will be awarded cups, diplomas and prizes. The coach of the winner team will be awarded diploma and prize.</p> <p><b>FINALS PER APPARATUS:</b> First 3 classified gymnasts in each age category will be awarded medals and diplomas. Gymnasts from 4th to 8th place will be awarded diplomas.</p>															
<b>VISA</b>	<p>Please verify immediately with your travel agent or the Embassy or Consulate in your country if a visa is required for your travel to <b>Portugal</b>. The Organizing Committee will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before <b>01.02.2018</b> to the LOC.</p> <p>The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to.</p>															
<b>INSURANCE</b>	<p>The Host Federation, the Organizing Committee and the FIG will not answer for any liabilities in case of accidents, illness, repatriation and the other.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p>															

	The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.												
<b>INTERNATIONAL TRANSPORTATION</b>	The invited participating federations must pay for the travel costs of their delegation members. The Travel Schedule Form must be returned to the LOC by <b>15.03.2018</b> .												
<b>LOCAL TRANSPORTATION</b>	Free local transportation from the nearest airport Porto (OPO) to the venue and return will be provided by the organizing committee. Shuttle bus will be available during competition days between hotel and sports hall.												
<b>ACCOMMODATION</b>	<b>Hotel Fundador – Guimarães ***</b> Av. D. Afonso Henriques, 740, 4810-912 Guimarães, Portugal  <b>60€ person/night</b> (double or triple room, including breakfast, lunch, dinner) - for 4 gymnasts, 1 coach, 1 judge per team <b>75€ person/night</b> (double or triple room, including breakfast, lunch, dinner) - for extra persons Single room is rated per person 90€ per night including breakfast, lunch and dinner. The prices charged for the hotel rooms will not exceed the usual hotel rates.  While the Accommodation form must be returned to the LOC by <b>15.03.2018</b> at the very latest, the Hotel rooms will be allocated on a “first come, first serve” basis.  <b>The invited participating federations must pay for the accommodation expenses of their delegation members.</b>
