## I. ARTISTICS GIMNASTICS

## 1. DATE AND PLACE

The Artistic Gymnastics competitions of the XI South American Games Cochabamba 2018 will be held in the Municipal Gymnastics Hall, located on Antonio Villavicencio and Monsignor Antezana Rojas streets of the city of Cochabamba, on Saturday, May 25<sup>th</sup> to Wednesday May 31<sup>st</sup>, 2018.

## 2. CATEGORY

Participating athletes will have at least sixteen (16) years in the female branch and eighteen (18) years in the male branch completed in the lapse of the year 2018.

All gymnasts must have a FIG licence valid until the end of the event.

## 3. EVENTS AND MEDALS

In accordance with the provisions of the ODESUR general competition regulation, it will be awarded in the following manner:

## 4. AWARD CEREMONIES

The awards ceremonies will be held at the scheduled times, respecting the regulatory period of INQUIRIES. For the awards ceremony, athletes must wear the official uniforms representative of their country, according to the protocol established by ODESUR.

The athletes to be awarded must present thirty (30) minutes before the scheduled time for the ceremony at the award site.

## 5. COMPETITION SYSTEM

The classifications corresponding to individuals and teams in both branches will be carried out in the following manner:

- Qualification: All Around Final (AA), Team Final (TF), and the list of gymnasts for Apparatus Finals (AF)
- Apparatus Finals

## 5.1. Team competition (CIV)

It will be done by adding the four (4) best grades obtained in each



apparatus in the Qualification Competition (system 6.5.4).

#### 5.2. ALL AROUND FINAL (AA)

It will be based on the total addition of points obtained in the four (4) equipments for women and six (6) apparatus for men in Qualification. With a maximum of two (2) per country.

#### 5.3. APPARATUS FINALS (AF)

The classification for the finals will be made with the eight (8) best gymnast (both women and men) in each apparatus and two (2) reserves, with a maximum of two (2) per country.

The evaluation of the Qualification Competition and Apparatus Finals will be established according to the regulations of the score code of the International Gymnastics Federation (FIG), edition 2017 - 2020.

#### 5.4. TIES

In case of a TIE in classification by teams, it will be a tiebreak according to the rules established by the FIG for the Olympic Games. (Refer to TR 2017, section 2, Art 4.4 for classifications and finals).

**GAF - Qualification:** entry to the competition area is allowed for up to two (2) coaches (one woman and one man or two women) for countries with teams; and a coach (male or female) for countries with individual female gymnasts.

**GAM - Qualification:** entry to the competition area is allowed for up to two (2) coaches (one woman and one man or two women or two men) for countries with teams; and a coach (male or female) for countries with individual male gymnasts.

In case of a TIE in the final result by teams (C IV) and general individual end (CII), refer to TR 2017, Art 4.4.2.

GAF / GAM - Individual Apparatus final: this will involve the eight (8) best gymnasts of Qualification in each apparatus, with a maximum of two (2) per country. In case of a tie in the final result, refer to TR 2017, Art 4.4.2. In Competition III, each gymnast can enter the competition area with a coach (male or female).



#### 5.4. Composition of the competition groups

The groups and competition order will be established by a draw of lots at the technical meeting with the delegates.

The competition program is provisional and subject to modifications.

## 7. TECHNICAL MEETING

It will take place on Friday, May 25, 2018, time and place to be defined.

Each National Olympic Committee can attend with two (2) representatives, only one (1) with the right to vote. If necessary to assist with an interpreter.

The technical delegate will preside over the meeting.

The meeting of judges will take place on Friday, May 25, time and place to be defined.



## 8. FACILITIES AND SPORTS EQUIPMENT

The Municipal Gymnastics Hall will have a competition and a warm-up sector.

The equipment will comply with the regulations established by FIG.

The trainings will be established once the inscriptions have been received and will be carried out instead of being defined.

The facilities can only be used at the times designated by the organizing committee.

## 9. PARTICIPANTS AND QUOTA (PLACES)

All athletes from countries affiliated with ODESUR and whose national federations are affiliated with the South American Gymnastics Confederation (Consugi) and the International Gymnastics Federation (FIG) will be able to participate.

Each country can register a team of each branch (male and female), consisting of six (6) athletes maximum and four (4) as a minimum.

A team shall provide for not more than Six (6) gymnasts, five (5) may compete on any single piece of apparatus and the 4 highest scores will be taken into account for the team total. Countries that do not register complete team will have the possibility of presenting one (1) to three (3) athletes as a maximum, which will participate as individuals.

These amounts will be part of the 40% integral of each delegation.

#### 9.1. Places minimum of countries

Each event will be enabled with a minimum of five (5) participating countries (Art. 29.1 and 29.2 of the ODESUR competition manual).

#### 9.2. Participation document

The passport is the only document that accredits the nationality of the athlete, being indispensable his presentation to be able to participate in the competition.

## 10. GENERAL REGULATIONS

The technical requirements for the classification and final by appliances will be applied according to the FIG score code, version 2017-2020.



Artistic Gymnastics competitions for men and women will be rule in accordance with the provisions of the FIG regulations.

Cases not provided for in this manual will be resolved as follows:

- If they are of a general nature: by the Organizing Committee of the XI South American Games Cochabamba 2018, in accordance with the ODESUR regulations.
- If they are of a technical nature: according to the FIG and Consigi rules.

The Organizing Committee will set the schedule of the events and these will be carried out under the supervision of the ODESUR technical committee.

The musical accompaniment must be recorded on CD, which must be delivered to the Organizing Committee at the technical congress, with a sign that contains:

- Name of the federation.
- Country.
- Name of the gymnast.
- Duration.
- Interpreter.

#### **10.1 Appeals**

Appeals will be made in accordance with technical regulation FIG 2017 section 1, Art. 8.4 with cost clarification for each appeal of USD 100.- (One hundred 00/100 US dollars) according to the Consugi rules. Appeals will be made in accordance a technical regulation FIG 2017 section 1, Art. 8.4 with the cost explanation for each appeal of USD 100.- (One hundred 00/100 American dollars) according to the Consugi regulation.

#### 10.2. Draws

In cases of draws these will be dealt with in accordance with the regulations established by the FIG for the Olympic Games. Refer to the technical regulation FIG 2017, section 2, Art 4.4 for classifications and finals.

#### 10.3. Uniforms

All international, national and auxiliary judges must present themselves in



the competition with the official uniform established by the FIG.

## **11. COMPETITION AUTHORITIES**

## 11.1. Technical organization

The responsibility for the technical direction of the event will be in charge of the Consugi, according to Art. 3.3 of the FIG regulations.

## 11.2. Judges and referees

The judges and referees participating in the competition must have a current valid FIG brevet corresponding to the XIV Cycle (2017-2020). The judges must know the score code and the technical competition regulation, in force on the date of the realization.

The conformation of the judges' panels will be drawn and designated according to what is established in the technical regulation of FIG.

All judges and assistants must report to the gym one hour (1h) before the start of the competition. Similarly, judges will be obliged to participate in all courses and meetings planned by the technical management of the event.

## 11.3. Superior jury

The superior jury will be integrated by the technical delegate of the Consugi and the presidents of the Technical Committees of the Consugi or their delegates.

## **II. RHYTHMICS GYMNASTICS**

## 1. DATE AND PLACE

The competition of Rhythmic Gymnastics of the XI South American Games Cochabamba 2018 will be held in the Gymnastics Hall, located on Antonio Villavicencio Street and Monsignor Antezana Rojas, in the city of Cochabamba, from Saturday 02 to Wednesday June 6, 2018.

## 2. CATEGORY

The minimum age of competition is 16 years old by the year 2018. All gymnasts must have a FIG licence valid until the end of the event.

## 4. AWARD CEREMONIES

The awards ceremonies will be held at the scheduled times, respecting the regulatory period of claims. For the awards ceremony, the athletes must wear the representative official uniforms of their country, according to the protocol established by ODESUR.

The athletes to be awarded must be presented 30 minutes before the scheduled time for the ceremony at the award site.

## 5. COMPETITION SYSTEM

The competition system will be according to the FIG for the world championships with changes in relation to the days of competition and number of participants.

#### 5.1. Individual Competition

#### A. Al-around individual competition


• 1 exercise with each of the apparatus imposed within the program

#### B. Finals by apparatus

• 1 exercise of each apparatus in which the gymnast is qualified.

#### 5.1.1. Qualification individual

The competition program includes the four (4) apparatus imposed by the program of the year concerned, as indicated in the following table.



For the athletes who participate in qualifications as individuals, the program is composed of three (3) or four (4) exercises performed with the imposed apparatus. Their classification determines the qualification for the all-around final ) that is obtained by the addition of the three (3) highest grade obtained, and for the finals by apparatus (Contest III), according to the note obtained in the apparatus in question. All athletes (maximum two (2) per national federation) who have participated in the



corcerning apparatus have the possibility of qualifying to participate in theall-around final and the apparatus finals.

#### 5.1.2. All-around - Individual

The ten (10) best athletes of the qualifications of the Qualifications take into account the maximum limit of two (2) athletes per national federation. Two reserve athletes are appointed taking into consideration the list of results. The called reserve athletes will compete according to the order of the athletes they replace. Reserve athletes should be ready in case they are called to compete.

The program consists of four (4) exercises, using respectively the four (4) apparatus imposed. The classification is obtained by the addition of the four (4) notes in the four (4) apparatus, without taking into account the results of the qualification (Contest I).



The athlete who has obtained the highest score in the sum of the notes of the four (4) exercises will be proclaimed champion.

#### 5.1.3. Individual final by Apparatus

The 8 best athletes (maximum two (2) per national federation) of the qualifications in each of the four (4) apparatus of the program are designated to participate in the individual finals per apparatus. Two (2) reserve athletes are appointed based on the score of qualifications. If they are called to compete, they will take the position of the athlete to replace. Reserve athletes must be ready in the case of being called to compete.

The athlete who has obtained the highest score in each apparatus will be proclaimed champion.



#### 5.2. Groups exercises

#### A. Qualifications (general competition)

• Two (2) exercises performed by five (5) athletes working in a group.

#### **B. Final by Apparatus**

- • One (1) exercise with each type of apparatus in which the group is qualified
- One (1) exercise with one (1) single type of apparatus, in which the group is qualified
- One (1) exercise with two (2) types of apparatus in which the group is qualified

## 5.2.1. Qualifications

The federations participating in the Qualifications must submit two (2) different exercises. One of the exercises must be executed with five (5) identical apparatus. The second exercise must be composed in the way you use the two (2) different Apparatus designated by the CT-FIG.

The national federations may register five (5) or six (6) athletes as a maximum for the complete program of the group exercises (two (2) qualifications and two (2) finals). If you present six (6) athletes, each one must execute at least one exercise. The group exercises must be performed by five (5) athletes. Groups composed of a different number of athletes are not allowed.

The music of the different exercises can be different or identical.

The group that obtains the highest score in the addition of the puntuation obtained in the two (2) years will be proclaimed champion.

## 5.2.2. End with one type of equipment / with two types of equipment

The four (4) first groups of the qualification in each of the types of apparatus are qualified to the final. A reserve group will be designated based on the classification of qualifications. If they are called to compete, they will take the position of the replaced group. Reserve groups should be prepared in case they are called to compete.

The group will be proclaimed champion with the highest score obtained for the exercise of the program.



#### **Musical accompaniment**

Each federation must follow the regulations of the RG CoP 2017-2020.

## 7. TECHNICAL MEETING

It will take place on Sunday June 3, 2018, time and place to be defined.

Each National Olympic Committee may attend with two (2) representatives, only one (1) with the right to vote. If necessary, you can assist with an interpreter.

The technical delegate will preside over the meeting.

## 8. FACILITIES AND SPORTS EQUIPMENT

The competition and the trainings will be developed in the respective areas of the Municipal Gymnastics Pavilion.

The equipment will comply with the regulations established by FIG.

## 9. PARTICIPANTS AND QUOTA (PLACES)

Athletes whose National Olympic Committees are affiliated with ODESUR and whose national federations are affiliated to the Consugi and the FIG.

The delegation of each country may be composed of a maximum of ten (10) athletes, to complete the following competition modalities:

- RGI: One (1) to four (4) Gymnasts.
- RGG: Six (6) Gymnasts.

Each country can present two (2) coaches and one (1) head of delegation.

These amount will be part of the 40% integral of each delegation.

#### 9.1. Places minimum of countries



Each event will be enabled with a minimum of five (5) participating countries (Art. 29.1 and 29.2 of the ODESUR competition manual).

#### 9.2. Participation document

The passport is the only document that accredits the nationality of the athlete, being indispensable his presentation to be able to participate in the competition.

#### 10. GENERAL REGULATION

The Rhythmic Gymnastics competition will be rule in accordance with the provisions of the FIG 2017-2020 regulations.

Cases not provided for in this manual will be resolved as follows:

- If they are of a general nature: by the Organizing Committee of the XI South American Games Cochabamba 2018, in accordance with the ODESUR regulations.
- If they are of a technical nature: according to the FIG and Consugi rules.

The Organizing Committee will set the schedule of the events and these will be carried out under the supervision of the ODESUR technical committee.

The difficulty cards and the musical accompaniment recorded on CD of the individual and overall athletes, must be delivered to the Organizing Committee in the technical congress, with a label that contains:

- Name of the federation
- Country, the 3 letters used by FIG
- Name of the athlete
- Equipment symbol
- CDS, name of the composer, name of the song and time of the music.

#### 10.1. Events

#### In the individual exercises

It will compete in the Qualifications and All-around Individual final. In a single participation, the result of the Qualification (general individual) will be defined and the classification of the eight (8) finalists will be made to the Allaround Individual Final in exercises with: Hoop, balls, Ribbon and Clubs.

#### In the Group exercises

Competition I and II will compete with two exercises in: five (5) Hoops, three



(3) balls and two (2) ropes.

#### 10.2. Appeals

Appeals will be made in accordance with technical regulations FIG 2017 section 1, Art. 8.4 with the cost explanation for each appeal of USD 100.- (One hundred 00/100 US dollars) according to the Consugi regulation.

#### 10.3. Draws

In case of a tie at any stage of the competition, it will be a tiebreaker according to the rules established by FIG for the Olympic Games. Refer to the technical regulation FIG 2017 section 3, Art 3.4 for classifications and finals.

#### 10.4. Uniform

Judges: all international judges must present themselves during the event with the uniform established by FIG.

## 11. COMPETITION AUTHORITIES

## 11.1. Technical Organization

The responsibility of the technical committee of the event will be in charge of the Consugi, in accordance with the regulations of FIG.

## 11.2. Judges and referees

The judges and referees participating in the competition must have a current valid FIG brevet in the respective discipline (RGI and/or RGG) in accordance with the provisions of the current FIG regulations, according to the first chapter for the current cycle.

#### 11.3. Superior jury

The superior jury will be integrated by the technical delegate of the Consugi and the presidents of the technical committees of the Consugi or its delegates.

The Trampoline Gymnastics competition of the XI South American Games Cochabamba 2018 will be held in the Gymnastics Pavilion, located on Antonio Villavicencio Street and Monsignor Antezana Rojas of the city of Cochabamba, from May 31<sup>st</sup> to June 2<sup>nd</sup>, 2018

## 2. CATEGORY

Participating athletes will have at least seventeen (17) years in both disciplines during 2018.

All gymnasts must have a FIG licence valid until the end of the event.

## 3. EVENTS AND MEDALS

In accordance with the provisions of the ODESUR general competition regulation, it will be awarded in the following manner:

## 4. AWARD CEREMONIES

The awards ceremonies will be held at the scheduled times, respecting the regulatory period of claims. For the awards ceremony, the athletes must wear the representative official uniforms of their country, according to the protocol established by ODESUR.

The athletes to be awarded must be presented 30 minutes before the scheduled time for the ceremony at the award site.

## 5. COMPETITION SYSTEM

The corresponding classifications will be carried out in the following way:



- Qualification individual female trampoline Competition: final individual female trampoline.
- Qualification male trampoline Competition: final male individual trampoline.

## 5.1. Qualification individual trampoline Competition (TRI)

It will be done by adding the final scores of two competition series of each athlete according to FIG 2017-2020 regulations for each branch.

## 5.2. Final Individual trampoline Competition (TRI)

It will be carried out according to regulations FIG 2017-2020. They will pass the eight (8) best athletes per branch, with a maximum of two (2) athletes per country per branch.

## 5.3. Composition of the competition groups

The groups and competition order will be established by drawing at the technical meeting with the delegates.

## 6. COMPETITION PROGRAM

The competition program is tentative and subject to modifications.

## 7. TECHNICAL MEETING

It will take place on Thursday, May 31, 2018, time and place to be



#### defined.

Each National Olympic Committee may attend with two (2) representatives, only one (1) with the right to vote. If necessary, you can assist with an interpreter.

The technical delegate will preside over the meeting.

The meeting of judges will take place on Monday, May 14, time and place to be defined.

## 8. FACILITIES AND SPORTS EQUIPMENT

The Gymnastics Pavilion will have a competition and a warm-up sector.

The equipment will comply with the regulations established by FIG.

The training program will be established once the inscriptions have been received and will be carried out in a place to be defined.

The facilities can only be used at the times designated by the Organizing Committee.

## 9. PARTICIPANTS AND QUOTA (PLACES)

All athletes from countries affiliated with ODESUR and whose national federations are affiliated with the Consugi and FIG.

Each country may register two (2) athletes from each branch.

Each country may submit two (2) coaches per branch and one (1) head of delegation.

They will be part of the 40% integral of each delegation.

#### 9.1. Places minimum of countries

Each event will be enabled with a minimum of five (5) participating countries (Art. 29.1 and 29.2 of the ODESUR competition manual).

#### 9.2. Participation document

The passport is the only document that accredits the nationality of the athlete, being indispensable his presentation to be able to participate in the competition.



#### 10. GENERAL REGULATION

The technical requirements for the classification and the final will be applied according to the FIG scoring code, version 2017-2020.

The Trampoline Gymnastics competitions will be rule in accordance with the provisions of the FIG regulations.

Cases not provided for in this manual will be resolved as follows:

- If they are of a general nature: by the Organizing Committee of the XI South American Games Cochabamba 2018, in accordance with the ODESUR regulations.
- If they are of a technical nature: according to the FIG and Consugi rules.

The Organizing Committee will set the schedule of the events and these will be carried out under the supervision of the ODESUR technical committee.

#### 10.1. Appeals

Appeals will be made in accordance with technical regulation FIG 2017, section 1, Art. 8.4 with the cost explanation for each appeal of USD 100.- (One hundred 00/100 US dollars) according to the Consugi regulation.

#### 10.2. TIES

In cases of draws, these will be dealt with in accordance with the regulations established by the FIG for the Olympic Games. Refer to the technical regulation FIG 2017, section 4, Art 2.4 for classifications and finals.

#### 10.3. Uniform

Judges: all international, national and auxiliary judges must present themselves during the event with the uniform established by FIG.

## 11. COMPETITION AUTHORITIES

#### 11.1. Technical Organization

The responsibility for the technical direction of the event will be in charge of the Consugi, according to Art. 3.3 of the FIG regulations.



#### 11.2. Judges and referees

The judges participating in the competition must have a current FIG brevet corresponding to the XIV Cycle (2017-2020).

The judges must know the score code and the technical competition regulation, in force on the date of the realization.

The conformation of the courts will be carried out according to what is established in Art.8.8.2 of the technical regulation of FIG.

All judges and assistants must report to the gym one hour (1h) before the start of the competition. Similarly, judges will be obliged to participate in all courses and meetings planned by the technical management of the event.

#### 11.3. Superior jury

The superior jury will be integrated by the presidents of the technical committees of the CONSUGI or their delegates and the general coordinators of the competition.

#### **IV. GENERAL GUIDELINES**

#### 12.INSCRIPTIONS

All countries through their National Olympic Committee must complete their registration process through the information system of the Organizing Committee, under instructions that will be sent to each National Olympic Committee.

It is necessary to send your requests to participate in sports in the official formats defined by the Organizing Committee. You must indicate in them the sports in which you intend to participate in the XI South American Games Cochabamba 2018.

#### 12.1. Numerical Inscription

The numerical inscription must indicate the amount (without specifying the names) of athletes, officials, technical and auxiliary bodies, in individual sports and by team that will make up the delegation. They must be received at the Organizing Committee of the XI South American Games Cochabamba 2018.



#### 12.2. Long list (preliminary nominal inscription)

The long list of athletes, officials, technical, administrative and auxiliary personnel must be sent to the Organizing Committee of the XI South American Games Cochabamba 2018 no later than hrs. 23:00 (Bolivian time) of February 14, 2017.

## 12.3. Nominal inscription

The Organizing Committee will receive the nominal registration of joint sports until April 11, 2018 at hrs. 23:00 (Bolivian time).

The Organizing Committee will receive the nominal registration of individual sports until April 26, 2018 at hrs. 23:00 (Bolivian time).

After the established date, changes of registration or incorporation of participants can't be made.

The Organizing Committee will validate the registrations only with the reception of the official forms, which must be duly signed and sealed by the authorities of the respective National Olympic Committee.

## 13. DOPING CONTROL

The doping control will be carried out as established by the ODESUR Medical Commission, the FIG regulations and the standards and recommendations of the World Anti-Doping Agency will be followed.
