SIZE OF DELEGATIONS	Delegation may consist of:  * 1 Head of delegation  * gymnasts, according to the competition rules (2-4 per team)  * 1 coach		
REGISTRATION DEADLINES	Definitive registration: 11 <sup>th</sup> February 2017 Nominative registration 19 <sup>th</sup> February 2017		
ENTRY FEES	No applicable

### **VISA** Please verify immediately with your travel agent or the Spanish Embassy or Consulate in your country if a visa is required for your travel to Spain. The LOC will be happy to assist each Delegation member with an official invitation letter, provided that the request is made before the 1<sup>st</sup> February to the LOC. The request must include the function, full name, gender, date of birth, citizenship and passport number, passport expiry date, the arrival and departure dates of the Delegation Member as well as the city the visa application support letter must be sent to. The Host Federation, the LOC and the FIG will not be held responsible for any **INSURANCE** liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the Federations own charge. **INTERNATIONAL** The invited participating federations must pay for the travel costs of their **TRANSPORTATION** delegation members. The Travel Schedule Form must be returned to the LOC by 19th February 2017. LOCAL Free local transportation from the Official Hotel to the Competition Venue **TRANSPORTATION** (and viceversa) and transfer from/to Malaga Airport and Railway Station will be provided for all Delegation members from Thursday 31st April to Monday 3rd March.
