AGE LIMITS	Senior Individual and Group – 16 years old (Born in 1999 or before)	
	All gymnasts must have a current valid license at the time of the event.

INVITED FEDERATIONS	All FIG member Federations are invited.
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like. The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation. The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance. The LOC will subsequently offer insurance at the participant federations own charge as follow: USD 50,00 per person / day.
ACCREDITATION	Accreditations will be made at the arrival of the Delegations. Heads of delegation have present to accreditation office: - Music: 2 CDS for each routine (clearly labeled with the gymnast's name, country, apparatus and category). - Valid passports of all delegation members; - CD with the national anthem and 1 national flags; - 10 FIG D forms for each gymnast. - Medical Insurance (obligatory for all delegation members) - Valid FIG Licences for gymnasts. A photo and passport of each member of the delegation (in electronic) must be sent together with the nominative registration dully labeled with the gymnast, country, apparatus, and gymnast category information as mentioned above at the latest by October 18th, to the e-mail; brazilian_gymnastics@cbginastica.com.br.
JUDGES	All Judges must have a current valid FIG Brevet minimum IV. The Organizing Member Federation will apply a fine of CHF 2'000 per missing judge (to be paid to the LOC) should a federation fail to bring the required number of judges. This fine must be paid to the LOC by October 18th , 2015 .
INTERNATIONAL	The invited participating federations must pay for the travel costs of their
TRANSPORTATION	delegation members. The Travel Schedule Form must be returned to the LOC by October 18th 2015 .
VISA	Please verify immediately with your travel agent or the Brazilian Consulate in your country if a visa is required for your travel to Brazil.
