	date, the arrival and departure dates of the Delegation Member as well as the city of the Bulgarian Consular Department to which the official visa support letter must be sent.	
	Note: Bulgaria applies a visa-free system for holders of <u>valid</u> Schengen visas.	
INSURANCE	The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.
