EVENT FORMAT	<u>Junior (FIG and UEG Rules)</u> Competition I Team competition with 2 - 4 gymnasts per federation; they have to present 8 exercises according to the junior programme, in the order of the apparatus fixed by FIG (rope, hoop, ball, clubs). A gymnast may participate with 2 - 4 exercises. The team result will be calculated based on the best 6 of the 8 presented exercises. Competition III Apparatus finals (4 apparatus) – the best 8 gymnasts per apparatus from Competition I according to the FIG Regulations (max. 1 gymnast per federation) <u>Senior (FIG Rules)</u> Competition II - All around Competition III – Finals (the best 8 gymnasts per apparatus – max 2 per federation)

INSURANCE	<p>The Host Federation, the LOC and the FIG will not be held responsible for any liabilities in case of accidents, illness, repatriation and the like.</p> <p>The FIG Technical Regulations foresee that all participating Federations are responsible for making their own arrangements to have the necessary valid insurance coverage against illness, accidents and for repatriation for all the members of their Delegation.</p> <p>The LOC will verify the insurance upon arrival of the delegation members (e.g. cover note or photocopy of the valid policy). Delegation members with insufficient insurance cover must inform the LOC in advance.</p>
